GAMES MARKET – CONDITIONS FOR PARTICIPATION

1. CONDITIONS FOR PARTICIPATION FOR VENDORS THAT WILL BE PRESENT

You must ensure a continuous presence at your booth on Saturday and/or Sunday.

The construction of the booth must be completed, and the vehicles moved to the car park before 10 a.m.

HOURS

The games market opens to the public at 11 am. However, your booth must be ready at 10am to receive the first buyers. Thanks to our Kickstarter campaign, it is possible to have early access to the games market. So there will be a few people present to find bargains on the market, 1 hour before it opens to the general public.

Saturday: 10 am - 8 pm

Sunday: 10 am - 6 pm

RATES

1 table / 1 day = 30€

1 table / 2 days = 50 €

Formula « sandwich » (1 sandwich + 1 cold beverage + 1 hot beverage) = 5€ / 1 day OR 8€ / 2 days

DEADLINES

Subscriptions are only valid after the receipt of a fully completed entry form and a full payment before 15 August 2018.

There is no possibility for reimbursement in the event of a cancellation or of lateness on behalf of the exhibitor.

REQUEST FOR PARTICIPATION

Requests for participation are subject to a screening. A refusal by the organizers is irrevocable and does not need to be substantiated.

During the construction and opening hours of the festival, the organizers may decide to exclude exhibitors who do not respect these regulations, who offer products that are not in accordance with the family character of the festival, or who disrupt the good order. In these cases, there will be no refunds or compensation.

Requests which contain a reserve or are incomplete are registered temporarily and without any commitment from vzw Ludiris.

EXCEPTIONAL PROVISIONS

If the festival can not proceed as planned due to force majeure or causes that are not under the control of the organization, or if we have to change dates, previously completed payments by exhibitors may be refunded after deduction of the fees and expenses incurred by the organizers of the event. This type of situation mainly occurs in case of unforeseen political or economic events, government decisions, or withdrawal of our license. In these cases, the organizers bear no liability whatsoever.

INSURANCE

VADEMECUM

The exhibitors take note of the conditions contained in the vademecum that will be handed to them and which contains the technical information about the festival, as well as the instructions about the management of the booths.

2. CONDITIONS FOR PARTICIPATION FOR VENDORS THAT WILL NOT BE PRESENT (STORAGE SALE)

Preliminary registrations are only valid after the receipt of a completely filled out entry form **before 15 August 2018**. You provide a sales price for each of the games on the form. It's also possible to register directly on site during the opening hours of the storage space.

The BGF volunteers will manage a storage space on **Friday, August 24th, 2018 from 5 pm to 8 pm**, on **Saturday, August 25th from 8:30 am to 10 am**, and on **Sunday, August 26th from 8:30 am to 10 am**.

You may submit **up to 10 games** in good condition. You will receive proof that you have handed your games over to us.

Opening hours of the market:

Saturday: 11 am - 8 pm

Sunday: 11 am - 6 pm

(the market will be opened earlier, exclusively for the backers of our crowdfunding campaign)

The organizers reserve the right to refuse games which are damaged or incomplete, or which are not fitting for a board and card games market.

The organization will take **a 10% commission** on sold games. The seller chooses when to collect their games and/or their gains from the sale from the volunteers, **no later than 8 pm on Saturday and 7 pm on Sunday**. You must collect everything at once. Regardless of when you bring the games in: they have to be picked up again before 7pm on Sunday! (the BGF will store the games during the nocturne)

Note: games that were not picked up before the market closes will be kept for 4 weeks at the head office of Ludiris vzw (Stalingradlaan 24, 1000 Brussels). After this period, games that were not collected will be considered a donation to Ludiris, the organizer of the festival.
